## Actions Based on Nara Women's University's Activity Index Established to Prevent the Spread of Novel Coronavirus Disease (Guide on Actions from June 1, 2020)

In response to the release of the emergency state declaration nationwide on May 25, the university has decided that action in each activity index will be taken according to the following phase levels. In order to secure safety for Nara Women's University and the society, please take action that complies with the phase levels of each activity index.

The one week from June 1 will be a preparation period, and from June 8, we plan to ease the restriction and shift to the phase level 1 in the "Index 2 Researches" and "Index 4 Entry to campus."

Although the emergency state declaration was released, we ask that all staff and students continue engaging in basic infection prevention measures and taking actions in light of a "new lifestyle" (requested by the Japanese government) designed to prevent the spread of infections. Not only restrictions on activities at the university but also self-restraint in activities in everyday life and revision of lifestyles are being requested. Please behave in a manner that complies with the requests, such as avoiding outings to places with "three Cs" and refraining from unnecessary and non-urgent business trips or travel.

The chart below shows basic principle guidelines on action, as specified by phase levels of each activity index, as of this point, and the writing in italic describes specifics on the guidelines. Please comply with them.

However, only in cases where such restriction will significantly hinder the progress of their senior research or thesis, undergraduate students may enter the campus, upon receiving permission from supervising teaching staff and taking utmost heed to prevent the spread of infection.						
		Entry to campus by graduate students -Entry to campus by graduate students from regions with high numbers of infected people is prohibited. However, if such restriction will significantly hinder the progress of their researches, such graduate students may enter the campus, upon receiving permission from supervising teaching staff and taking utmost heed to prevent the spread of infectionEntry to campus by graduate students from regions with low numbers of infected people is permitted, upon receiving permission from supervising teaching staff.						
		Entry to campus by external persons is prohibited -Entry to campus by affiliated persons (vendors) is permitted.
